Dumpsters will be available for use by DeSoto residents during Annual Clean-up week. Proof of DeSoto residency such as a driver's license or utility bill will be required in order to use the dumpsters.

# Dumpsters Will Be Available During the 11th Annual City-Wide Clean-Up!!!

Clean out your garage, pick up your yard and bring your trash to the dumpsters located just south of DeSoto West Junior High on the east side of Westmoreland Road. Hazardous materials including paint, oil, chemicals, batteries and tires will not be allowed in the dumpsters. Tires can be recycled for a fee of \$2 each. City employees will be on hand to **assist** residents with placing items into the dumpsters and will ensure that no illegal dumping of waste or hazardous materials occurs. The dumpsters are provided for DeSoto residents only and proof of residency is required. Please be prepared to present a driver's license or utility bill with a DeSoto address as you enter the dump site.

Dumpsters will be available on Westmoreland at Spinner for the use of DeSoto residents only, on Saturday, April 14th, 9: a.m. to 7 p.m., Sunday, April 15th from 1 to 5 p.m. and Monday April 16th through Friday, April 20th, from 3 to 7 p.m.

# **DeSoto Recreation Center**

Spring is almost here and if you're ready to get in shape, look no further than the DeSoto Recreation Center.

DeSoto residents or employees of DeSoto

businesses can purchase a Recreation Pass for \$10 per year (seniors 55 & older are \$5) which entitles you to use the basketball gyms, the indoor jogging/walking track and game area. For an additional \$20 per month, you can use the state-of the-art Fitness Center equipped with universal weight machines, free weights, recumbent and stationary bikes, and ellipticals equipped with personal TVs. The center also offers fitness classes



including Jazzercise, yoga, a seniors exercise class, quick cardio and body sculpting and a spin class.

# What Does the City's Trash Service Pick Up???

As a resident of DeSoto, you already pay for the following trash disposal services each month with your utility bill:

- Twice a week Household Garbage Pick-up Residences east of Hampton Road have Monday/Thursday
  service and those west of Hampton Road have Tuesday/Friday pick-up of regular household garbage.
  It must be placed out for pick-up in the alley or front curb (where applicable) by 7:00 a.m. on the day
  of pick-up and the garbage must be placed in a plastic refuse bag.
- Once a Week Recycling Pick-up Each residence has recycling pick-up every Wednesday that includes
  plastic, glass, cardboard, paper of all kinds and junk mail.
- Once a Week Bulky Item Pick-up Items collected include old furniture, mattresses, hot water heaters, and appliances. Hazardous materials such as paint, pesticides, and tires will not be collected. Bulky items are collected on the second household garbage day for each residence. Items should be placed with your regular trash for pick-up. Construction materials are not accepted.
- Once a Week Brush Pick-up Place loose brush and tree limbs or old fencing/lumber out IN FRONT of your residence by the curb for pick-up. A truck will automatically come by within seven days to remove the brush

# Your Input is Needed on the Future of the Tri-City Animal <u>Shelter</u>

The Tri-City Animal Shelter is jointly owned and managed by the Cities of Cedar Hill, Duncanville and DeSoto. The City of Cedar Hill on behalf of it's partner cities, has hired Quorum Architects to conduct a needs assessment for the Tri-City Animal Shelter. This needs assessment will determine current needs, expansion possibilities for the facility and cost.

The first step in the process is to seek input from the public relative to the shelter by holding public meetings in all three cities. The City of DeSoto will host a meeting to gather public input on the Tri-City Animal Shelter in the City Council Chambers at DeSoto City Hall on Wednesday, March 21, 2007 at 7 p.m. DeSoto City Hall is located in Town Center at 211 E. Pleasant Run Road.

# Code Enforcement Encourages You to be Their Eyes & Ears

DeSoto's Code Enforcement Department has offered a program for several years called Eyes & Ears which enlists the help of homeowners association members by asking them to report code violations such as high grass or junk cars in their neighborhood. That program was expanded last year allow HOA members an even greater opportunity to make a difference in their neighborhoods. In addition to reporting high grass, the Eyes & Ears Program was expanded to empower registered Homeowners Associations to mow high grass and weeds at vacant homes in their neighborhood.

As we move into spring, neighborhoods may start to experience problems with high weeds. The Expanded Eyes & Ears program allows HOAs to be proactive in resolving the problem by following these procedures. When a high grass complaint at a vacant house is reported, a Code Enforcement Officer verifies that a violation exists and confirms with the City's Water Department that the property is vacant. A high grass sign is placed in the yard of the vacant property and digital photos are taken of the property for documentation purposes including the date and time of the photo. The property owner is then notified and has seven (7) days to mow the property. On the eighth day, the Code Enforcement Officer will re-inspect the property and if it has not been mowed, the neighborhood's Homeowners Association is notified and members of the HOA can mow the property.

Before this program was instituted, mowing contractors were hired to mow the vacant property extending the time before the property was mowed. Now HOA members can mow the property as soon as they are notified by Code Enforcement giving them some control over the appearance of their neighborhood. This gets the mowing done more quickly in most cases. Property owners are billed for the mowing and the HOA is paid \$50 for each yard mowed under this program.

HOA members in the Wildwood neighborhood recently took that initiative one step further. When faced with a home going through foreclosure in their neighborhood which had been vandalized with graffiti and had a damaged fence, they didn't wait for the mortgage company to address the problems. As Eyes & Ears Program participants, Wayne Valentine and Reginald Jones along with other Wildwood residents, painted over the graffiti and repaired the downed fence.

"The best way to keep your neighborhood looking clean and free of eyesores is to partner with the City's Code Enforcement Department and participate in the Eyes & Ears Program," according to Wayne Valentine, President of the Wildwood HOA. "I encourage you to be involved and monitor what is going on in your neighborhood by reporting high grass, graffiti, junk cars and other problems."

In order to participate in the Eyes & Ears Program, the Homeowners Association must be registered with the City of DeSoto Community Initiatives Manager. For more information or to participate in this program, please call the City of DeSoto Action Center at 972 274-CITY.

# Voters Will Consider Amendments to the City Charter at May 12th City Election

The DeSoto City Charter contains a provision requiring that this document be reviewed at least every five (5) years. In compliance with this provision, the DeSoto City Council appointed a 21 member Charter Review Commission in November chaired by former DeSoto Mayor, Richard Rozier. This Commission met several times to review the entire Charter and brought fourth their recommended revisions to the City Council in a joint meeting on January 30, 2007.

Based on the recommendations from the Charter Review Commission, the City Council has called a special election for May 12, 2007 to consider amendments to the Home Rule Charter for the City of DeSoto. Here are the propositions to be considered by voters:

### PROPOSITION 1

Shall Article XI, Sections 3, 4, 6, 10 and 11 of the DeSoto Home Rule City Charter regarding franchises and public utilities be amended to comply with state law?

# PROPOSITION 2

Shall Article II, Section 2 of the DeSoto Home Rule City Charter be amended to clarify the composition of the Boards and Commissions of the City?

## PROPOSITION 3

Shall Article IV, Section 7 of the DeSoto Home Rule City Charter be amended to clarify the number of signatures required on a petition for recall of a City Councilmember?

### **PROPOSITION 4**

Shall Article VIII, Section 1 of the DeSoto Home Rule

City Charter be amended to authorize the expenditure of more funds on a bond project than were approved by the voters upon a vote of 5 of the 7 City Councilmembers after a public hearing with prior notice to the public?

### **PROPOSITION 5**

Shall Article II, Section 1 of the DeSoto Home Rule City Charter be amended to eliminate term limits for the Mayor and City Councilmembers?

In addition to the Charter Election, voters will be asked to cast ballots for candidates for Mayor and City Council Places 3 and 5 during the May 12th City Election. In order to vote in the election, you must be a registered voter in the City of DeSoto. Voter registration applications are available at City Hall and the deadline to submit your completed application to Dallas County Elections is April 12, 2007.

Early voting for the May 12th election takes place in the DeSoto Library Assembly Hall from April 30th through May 8th. When you come to vote, please remember to bring your Voter Registration Card or another form of picture identification that indicates your current address. Taking advantage of the early voting option saves time and allows you to avoid the long lines on Election Day.
