

Applications for ballot by mail must be received no later than the close of business on Tuesday, April 20, 2021.

- A ballot that is mailed or delivered by common or contract carrier but does not have a postmark or delivery receipt must be received by the early voting clerk by 7:00 pm on Election Day.
- A ballot that is mailed or delivered by mail or common or contract carrier from within the United States and is postmarked or accompanied by a delivery receipt showing the voter submitted the ballot for delivery by 7:00 pm on Election Day must arrive by 5:00 pm on the next business day after Election Day.

- A ballot that is hand delivered must be received by the early voting clerk by 7:00 pm on Election Day. A ballot that is mailed from overseas and is postmarked or accompanied by a delivery receipt showing the voter submitted the ballot for delivery by 7:00 pm on Election Day must arrive by 5:00 pm on the 5th day after Election Day (or the next business day after the 5th day after Election Day, if the 5th day falls on a weekend or holiday).

If you are faxing or emailing your Application for Ballot by Mail, please note: The original application (hard copy) **MUST ALSO BE** submitted by mail and be received by Dallas County Elections Department no later than the **fourth (4th) business day** after the fax and/or email (scanned application must contain voter's original signature) was received.
