Dallas County Reports 112 New Positive 2019 Novel Coronavirus (COVID-19) Cases and 4 Deaths, Including 34 Probable Cases

DALLAS -- As of 12:00 pm June 9, 2021 Dallas County Health and Human Services is reporting 112 additional positive cases of 2019 novel coronavirus (COVID-19) in Dallas County, 78 confirmed cases and 34 probable cases. There is a cumulative total of 261,334 confirmed cases (PCR test). There is a cumulative total of 42,937 probable cases (antigen test). A total of 4,081 Dallas County residents have lost their lives due to COVID-19 illness.

Dallas County Health and Human Services (DCHHS) is providing initial vaccinations to those most at risk of exposure to COVID-19 and over 486,000 total doses of COVID-19 vaccine have been administered at the Fair Park mega-vaccine clinic, which started operations on Monday, January 11. The additional deaths being reported today include the following:

- A man in his 60's who was a resident of the City of Garland. He had been critically ill in an area hospital and had underlying high risk health conditions.
- A woman in her 70's who was a resident of a long-term care facility in the City of Garland. She had been critically ill in an area hospital and had underlying high risk health conditions.
- A man in his 70's who was a resident of the City of Rowlett. He had been critically ill in an area hospital and had underlying high risk health conditions.
- A woman in her 70's who was a resident of a long-term care facility in the City of Mesquite. She had been hospitalized and had underlying high risk health conditions.


The provisional seven-day average of daily new confirmed and probable cases (by date of test collection) for CDC week 21 (week ending 5/29/21), was **92**, which is a rate of **3.5** daily new cases per 100,000 residents. Over the past 2 weeks, rates of new COVID-19 diagnoses in the cities of Addison, Cockrell Hill, Seagoville have been about 50% higher than county-wide case rates. Rates of new COVID-19 diagnoses in the cities of Carrollton, Cedar Hill, Mesquite, Rowlett, and Wilmer have been about 30% higher than county-wide case rates. As of the week ending 5/29/2021, about **52% of Dallas County residents age 12 years and older** have received **at least one dose** of COVID-19 vaccine, including: 81% of residents age 65 years and older; 60% of residents between 40-64 years of age; 46% of residents 25-39 years of age; 35% of residents 18-24 years of age; and **15% of residents 12-17 years of age**.


During the week ending 5/29/2021, 93% of COVID-19 cases diagnosed were in Dallas County residents who were not fully vaccinated. In Dallas County, 580 cases of COVID-19 breakthrough COVID-19 infections in fully vaccinated individuals have been confirmed to date, of which 110 (19%) were hospitalized, 24 have required ICU admission and 10 have died. During the months of April and May, 20% of all COVID-19 cases diagnosed in Dallas County were in children under the age of 18 years—the highest proportion in this age group since the beginning of the pandemic. To date, 67 children have been hospitalized with diagnoses of multisystem inflammatory syndrome (MIS-C), a rare but serious complication associated with COVID-19 infection.

Of symptomatic patients presenting to area hospitals in week 21 (week ending 5/29/21), **6.0%** of respiratory specimens tested positive SARS-CoV-2. In week 21, area hospital labs have continued to report increasing proportions of respiratory specimens that are positive for other respiratory viruses by molecular tests: parainfluenza (35.9%), rhinovirus/enterovirus (33.8%) and RSV (10.5%). To date, a total of 135 cases with SARS-CoV-2 variants of concern have been identified in residents of Dallas County, including: 106 cases of variant B.1.1.7; nine B.1.429 variants; three B.1.526 variants; twelve P.1 variants; one P.2 variant, and four B.1.617.2 variants. Ten have been hospitalized with 4 requiring intensive care unit admission, and two have died. One fully vaccinated patient subsequently became ill from B.1.1.7 infection and died.

There are currently 13 active long-term care facility outbreaks. A cumulative total of 4,395 residents and 2,478 healthcare workers in long-term facilities in Dallas have been diagnosed with COVID-19. Of these, 1,118 have been hospitalized and 798 have died. About 20% of all deaths reported to date have been associated with long-term care facilities. Five outbreaks of COVID-19 in congregate-living facilities (e.g. homeless shelters, group homes, and halfway homes) have been reported in the past 30 days. A cumulative total of 638 residents and 224 staff members in congregate-living facilities in Dallas have been diagnosed with COVID-19. Local health experts use hospitalizations, ICU admissions, and ER visits as three of the key indicators as part of determining the COVID-19 Risk Level (color-coded risk) and corresponding guidelines for activities during our COVID-19 response. The most recent COVID-19 hospitalization data for Dallas County, as reported to the North Central Texas Trauma Regional Advisory Council, can be found at www.dallascounty.org/covid-19 under “Monitoring Data,” and is updated regularly. This data includes information on the total available ICU beds, suspected and confirmed COVID-19 ER visits in the last 24 hours, confirmed COVID-19 inpatients, and COVID-19 deaths by actual date of death. During the week ending May 29, 93% of COVID-19 cases diagnosed in Dallas County residents were individuals who were not fully vaccinated. We know that the vaccine is safe and effective. Please don't delay and get vaccinated today.

I want to remind everyone that the tax deadline was extended until Tuesday, June 15th due to the winter weather disaster. In order to receive the stimulus funds from the government, you need to file your taxes by the 15th. Additionally, all first and second Economic Impact Payments have been issued. If you didn't receive a payment or didn't receive the full amount of a payment, you may be eligible to claim the Recovery Rebate Credit when

The Centers for Disease Control and Prevention (CDC) recommends taking everyday preventive actions to help prevent the spread of respiratory diseases, including:

- Avoid close contact outside your home: Put 6 feet of distance between yourself and people who don’t live in your household.
- Cover your mouth and nose with a cloth face cover when around others and continue to keep about 6 feet between yourself and others. The cloth face cover is not a substitute for social distancing.
- Stay home when you are sick, except to seek medical care
- Wash your hands often and with soap and water for at least 20 seconds and help young children to do the same. If soap and water are not available, use an alcohol-base hand sanitizer with at least 60% alcohol.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Clean and disinfect frequently touched objects and surfaces daily using a regular household cleaning spray or wipes.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash. If you do not have a tissue, use your sleeve, not your hands. Immediately wash your hands.
- Monitor your health daily. Be alert for symptoms. Take your temperature and follow CDC guidance if symptoms develop.
